STEP 1 Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

Refer to PIC 3. Remove existing armrest plate and pad assembly by removing the four (4) screws located on the bottom of the arm and armrest pad assembly. Set hardware aside, it will be reused.

Carefully remove the pad from the existing armrest plate. Set pad

Locate provided Left Passenger Armrest Plate Replacement and

Place the Belleville washer, with the protruding curved side facing down towards the head of the screw, onto the screw. The protruding side of

the Belleville washer should be touching the flat washer.

STEP 7 Refer to FIG 2 and 3.

IF INSTALLING A <u>DRINK HOLDER</u> (SOLD SEPARATELY) OR <u>TECH-</u> <u>CONNECT</u> (SOLD SEPARATELY) TO ARMREST PLATE, ASSEMBLY PARTS IN THE FOLLOWING ORDER:

- Insert the screw and washer assembly from the bottom side of the drink holder mount.
- Apply a small amount of grease to both sides of the Brass Thrust.
 Place the Brass Thrust onto the protruding screw.
- Insert the hardware, attached to the drink holder or Tech-Connect mount, into the bottom mounting hole of the armrest plate. Tighten to your desired preference of sway/non-sway.
- On the inside of the armrest plate, fasten the lock nut to the protruding screw.
- Locate Keyhole End Pin and apply a small amount of Red Loctite to it. Fasten the pin to the screw.
- Attach the OEM passenger armrest pad, that was removed in Step 3, to the armrest plate assembly.

IF <u>NOTHING</u> IS BEING INSTALLED TO ARMREST PLATE, ASSEMBLY PARTS IN THE FOLLOWING ORDER:

- Place the Brass Thrust onto the screw and washer assembly.
- Insert the hardware, attached to the drink holder or Tech-Connect mount, into the bottom mounting hole of the armrest plate. Tighten to your desired preference of sway/non-sway.
- On the inside of the armrest plate, fasten the lock nut to the protruding screw.
- Locate Keyhole End Pin and apply a small amount of Red Loctite to it. Fasten the pin to the screw.
- Attach the OEM passenger armrest pad, that was removed in Step 3, to the armrest plate assembly.
- **STEP 8** Refer to PIC 5. Align and place the armrest assembly onto the arm.

STEP 9 Locate the four (4) screws that were removed in Step 2. Apply a small amount of Red Loctite to each screw. Fasten armrest assembly to the arm using the four (4) screws.
